
# Family Offer:

#### **TERMS & CONDITIONS**

- The above rates are quoted in Swiss Francs and are NET rates.
- VAT (currently at 3.8%) is included; any change in VAT will be applied and communicated accordingly.
- The city tax will be added upon departure (currently at Chf. 4.75 per person and per night, subject to be changed by Geneva City).
- Rates are considered per room, per night, for single or double occupancy.
- Third person cost in double occupancy room (only valid from the executive room category):
  - Up to 3 years old: free of charge.
  - o Between 4 and 14 years old: only the breakfast at Chf. 25.00 will be charged.
  - From 15 years old and above, extra bed is at Chf.150 per person, per day including breakfast.
- Above rates are considered for individual bookings only for the incoming International leisure market, neither corporate, nor group (7 rooms or less).
- The special offers "Week-end Offer", "Family Offer" and "Early Booking" cannot be combined and cumulated.

# CANCELLATION AND PAYMENT POLICY

- Cancellation policy: by 3 p.m. local hotel time, 24 hours prior to arrival.
- Payment policy: all invoices must be settled within 30 days of invoice date. If payments are not received in due time, the hotel has the right to revoke this agreement or request prepayment.
- Validity of the above payment condition is subject to the hotel receiving details of your company credit card and the cardholder's signature.

#### **RATES PUBLICATION**

- The special Wholesalers rates contracted between the wholesaler company and La Réserve Genève Hotel and Spa are exclusively intended for « business to business » use. Consequently, these net Wholesalers rates must be used in the context of a re-sale with a professional in the tourism industry (such as a tour operator or a travel agency), necessarily implying the application of respective and successive financial margins. In the context of a direct sale to the end-consumer, the application of these net rates is therefore excluded from the contract.
- By signing this contract, the person / entity must respect the minimum rates to be disclosed to the end-consumer therefore must avoid any rate parity issues. These rates, net of commission, correspond to the hotel's « cap» rates which may be disclosed to the end-consumer, whatever the means of promotion/sale used (third party website, publications...). This implies a full responsibility from the person / entity signing this contract towards the distribution of our net rates to its partners / affiliates. Imparity issues caused by the signing party / entity's negligence will have to be resolved immediately and will be subject to compensation to La Reserve Geneve for its loss of revenue.
- In the event of any promotion of the hotel via a website or any other promotional support (emanating from the Wholesalers or one of its partner), the person signing this contract must communicate the names of these websites to the hotel and, if necessary, send to the hotel a copy of any publication promoting the hotel.
- In the event that the hotel was to discover any publication of these net rates to an end-consumer, with a margin not observing a parity with La Réserve Genève public rates, and whatever the promotional support used (brochure, website...), the hotel reserves the right not to honour the reservations concerned and to terminate this contract with immediate effect, by means of a Registered Letter with Request for Acknowledgement of Receipt.
