- e) No-shows are charged with one night no-show fee at 100% of the agreed room rate. If voucher payment is accepted, the payment is requested within 30 days from the date of the invoice by bank transfer.

The Management reserves the right to terminate the contract agreement without prior notice if the above payment conditions are not respected.



# 5. Article V. Cancellation Policy

FIT rates: cancellations allowed 24 hours (by 6 p.m.) before day of arrival, at no charge.

For No Show or late cancellations hotel will charge 100% of the first night.

Renaissance Tuscany Il Ciocco Resort and Spa recommends check-in after 2 p-m. hrs to ensure that rooms are ready, checkout time is 12 a.m. noon.

## 6. Article VI. - "Force majeure"

Any event of "force majeure" beyond control of the hotel will discharge both parties there under from any duties arising out of this arrangement. Considered as a force majeure are for example the following events: war riots, strike, and breakdowns of supply facilities. It is agreed that no contractual party shall be liable for any claim or damage resulting from relocation, whether direct or indirect.

## 7. Article VII. Selling Conditions

If the operator does not sell at 20% of the allotment during the first six months of the contract then hotel is entitled to release the rooms in allotment for the remaining period of the contract prior to written communication.

#### 8. Article VIII. – Miscellaneous

- a. This Agreement shall be executed in two (2) copies, each of which shall be deemed to be an original.
- b. The law of the Italian Republic shall govern this Agreement.
- c. This Agreement shall come in force and become effective upon its signing by both Parties.
- d. This Agreement shall be executed in the English language.
- e. Any changes or amendments to this Agreement shall be made in writing.
- f. This agreement is only valid if signed for acceptance by both parties.
