
# **ALLOTMENT MATERIALIZATION**

Grand Hyatt Cannes – Hotel Martinez will monitor the number of rooms actually allocated every 6 months. Should the number of rooms allocated fall below 50 % of the contracted room allocation in any given 6-month period, Grand Hyatt Cannes – Hotel Martinez reserves the right to reduce the allocation accordingly with immediate effect.

## COMMISSION ON BAR (BEST AVAILABLE RATE)

Grand Hyatt Cannes – Hotel Martinez offers a commission of 20% on Public Best available rates (BAR) valid on all rooms and Suites available on our website.

This commission is calculated on the basis of the ROOM ONLY rate (VAT of 10% excluded). The VAT rate might be subject to change during the contracted period in case of French Governmental VAT review.

#### 2. CHECK-IN and CHECK-OUT TIMES:

#### 3. CANCELLATION and NO-SHOW POLICY FOR INDIVIDUALS:

All cancellations must be received in writing by fax or e-mail.

- Low Season:
  - Up to 24 hours prior to arrival = no charge
  - Within 24 hours prior to arrival = 50 % of total stay and 100 % for 1 night stay
- Medium Season:
  - Up to 24 hours prior to arrival = no charge
  - O Within 24 hours prior to arrival = 50 % of total stay and 100 % for 1 night stay
- High Season:
  - O Up to 72 hours prior to arrival = no charge
  - Within 72 hours prior to arrival = 50 % of total stay and 100 % for 1 night stay
- Peak Season:
  - Up to 7 days prior to arrival = no charge
  - O Within 7 days prior to arrival = 50 % of total stay and 100 % for 1 night stay

No allowance, restitution or compensation shall be paid if the stay is shortened or interrupted for any reason whatsoever.

#### 4. CHILDREN POLICY:

Children up to 12 years stay for free when sharing their parents' room:

- Inclusive of buffet breakfast in the breakfast room.
- Baby cots and roll-away beds are free of charge, subject to availability.

#### 5. PAYMENT CONDITIONS:

Grand Hyatt Cannes – Hotel Martinez accepts voucher payment if you have credit facilities with the hotel. Credit will only be granted if a credit application has been filled out and approved by Grand Hyatt Cannes – Hotel Martinez's credit department.

For Long stays exceeding 10 days, Suites bookings and for any booking of 25.000€ or more a specific cancellation and prepayment policy applies and will be communicated at the time of booking.

It is the responsibility of the contracting party to ensure that each guest has a voucher on arrival or advance payment has been made prior to guest arrival. Guests without the necessary vouchers will be charged at the rate of the day and will be required to settle the bill upon checkout.

All other related expenses (phone, options, extra meal expenses, etc. not included in the booking voucher) shall be paid by the Client at the end of the stay directly at the Hotel reception desk.

All invoices must be settled within 30 days after the invoicing date. In case of non-compliance with the payment conditions, Grand Hyatt Cannes – Hotel Martinez reserves the right to charge 0.1 % interest per day of the total outstanding balance.

## 6. INSURANCE:

The hotel has public liability insurance for all its guests.

Tour Operators have sole legal liability toward his agents, the Hotel, guests of the Hotel or more generally to any third party for any damages resulting from the provision of their services. In any case, the Hotel cannot be held liable for acts committed by the service providers or their agents. Said agents act under the sole responsibility of the service provider.

Service providers provide guarantees to the Hotel for any direct or indirect physical, material or immaterial damage that may arise from the provision of their services or the intervention of one of their agents, or more generally any third party appointed by them.

Tour Operators or their representatives shall be insured for liability incurred from any of the services they render with an insurance company that is known to be solvent. For water or landbased activities a minimum insurance of USD 500,000.00 per activity must be provided. For provision of transport services, minimum personal accident insurance coverage must be USD 25,000.00 per passenger seat.

#### 7. DISTRIBUTION OF RATES ON THE INTERNET

Grand Hyatt Cannes Hotel Martinez has the right to refuse to be present on a website or any other reservation channel selected by the Tour operator for the purpose of onward distribution of contracted products and services as provided by Grand Hyatt Cannes Hotel Martinez.



In a Business to Business (B2B) environment the Tour operator may onwardly distribute the contracted products and services of Grand Hyatt Cannes Hotel Martinez

Should the contracted products and services pass at any stage through onward distribution into a Business to Consumer (B2C) environment; the operator will undertake to package additional products and or services together with those contracted with Grand Hyatt Cannes Hotel Martinez in such a way that the separate elements of the package remain opaque.

At no point must any contracted product or service pass into a B2C distribution environment unpackaged unless respecting at all times the Grand Hyatt Cannes Hotel Martinez Best Rate Guarantee policy with its own B2C Website.

Rates are confidential and are not to be disclosed directly to the consumer and may ONLY be used to form the basis of a package.

The operator may not sell the contracted net rates on any consumer Internet website either directly or via a secondary agent. The contracting agent is deemed responsible for the selling practices of the secondary agents.

The distribution of any net rate (room only or B&B) through a website or Global Distribution System is STRICTLY FORBIDDEN unless prior approval has been granted in writing from Hyatt International.

To qualify as a PACKAGE RATE, it must be sold and promoted on-line as part of a product that includes OTHER elements and UNDER NO CIRCUMSTANCES may the package be sold or promoted on-line as ROOM ONLY/ B&B.

All rates indicated in this contract cannot be resold under any circumstances to an Internet website / vendor / wholesaler / distributor without being packaged with the fares of a selected airline partner (Fully Inclusive Tour), or must be sold to a valid Tour Operator for such purposes.

If the rates indicated are re-sold to a third party, the hotel must be informed of said party's company details and is entitled to terminate this contract if the third party is guilty of any breach of the contractual terms and conditions.

The Tour Operator agrees to feature the Grand Hyatt Cannes – Hotel Martinez in his brochure and to provide the Grand Hyatt Cannes – Hotel Martinez with a copy of the layout (text and images) for proofreading prior to printing. Pictures on a CD-ROM may be requested from the hotel.

Any breach of these conditions shall lead to the immediate termination of the contract. All rates and conditions are subject to change within 30 days of written notice.

#### 8. COMPLIANCE WITH APPLICABLE LAW AND REGULATIONS

The Tour Operator shall comply with all laws, regulations and all general or special requirements applicable to his activities.

In particular, the Tour Operator declares and guarantees:

- that he respects and upholds the general and specific obligations laid down in laws, regulations, professional agreements and / or case law relating to hygiene, health, environment and safety of people and assets;
- that he complies with the laws and regulations covering the services and / or products he provides in connection with the provision of his services, notably with regard to health and safety, particularly the health, phytosanitary, veterinary and hygiene rules generally related to the qualities and characteristics of the methods, processes, products, etc. used to perform the services;
- He ensures compliance with the law and regulations relating to the fight against undeclared work;
- He respects and ensures that his agents, subcontractors and co-contractors respect laws and regulations relating to privacy and to processing and protecting personal data, and hence ensures the implementation of all appropriate measures.

# 9. DURATION AND TERMINATION

This rate agreement shall be activated once <u>one original copy</u>, duly signed by an authorized signatory, initialed on every page and stamped, has been returned to and accepted by Grand Hyatt Cannes – Hotel Martinez.

It shall be in force for a period of one year following its acceptance by Grand Hyatt Cannes – Hotel Martinez.

The Contract may be terminated without prior notice by registered letter with acknowledgment of receipt for the following reasons and under the following conditions:

If one Party defaults on any of its obligations laid down in the Contract, the other Party may send the defaulting party a letter of formal notice with acknowledgment of receipt. The defaulting

Party shall remedy its shortcoming within a 15-day period which shall run from the first presentation of said letter with acknowledgment of receipt;

If the notice remains without effect, the Party who sent the notice shall terminate the Contract by sending a registered letter with acknowledgment of receipt to the defaulting party;

The termination date shall be that of the first presentation of the registered letter with return of said receipt.

## 10. CLOSURE OF THE HOTEL

In case of closure of the HOTEL for whatever reasons, this one will have the possibility of modifying, of suspending or of cancelling the current contract without compensation.

#### 11. FORCE MAJEURE

In the case of force majeure events beyond the Hotel's control, or for safety or maintenance reasons, the Hotel may, as required by circumstances, have to partially or completely change its stays (total or partial closure of the Hotel, of common equipment, etc.). In such circumstances, the Hotel shall inform the Tour Operator in a written document sent by fax or e-mail within 24 hours of the date on which the event occurred. The Contract between the Hotel and the Tour Operator shall be automatically suspended as a matter of right from the date of the occurrence of the event without any compensation. If the event lasts more than 30 days from the date of its occurrence, the Contract may be terminated by either party, with neither party being entitled to any award of damages. Such termination shall take effect on the date of the first presentation of the termination letter with acknowledgment of receipt.

#### 12. APPLICABLE LAW

This Contract is subject to French law. Any dispute arising on the occasion or in connection with its conclusion, execution or termination shall be submitted to the jurisdiction of the competent Paris law court.
