#### 1. RATES

- **1.1.** Rates are in Euro, per day, including Buffet Breakfast and 10% VAT, and are NET hotel. **Should VAT increase, rates will be updated accordingly.**
- 1.2. City tax EUR 6,00 p.p. per day not included (to be paid cash upon departure)
- **1.3.** Children policy: child up to 2,99 year in baby cot: free of charge. From 3 years up, see triple rate.
- **1.4.** Rates apply to the leisure, individual market.
- **1.5.** The rates contained in this contract will not apply to Groups, Conventions, Meetings or Incentives, which will be quoted on request.

## 2. RESERVATIONS/CANCELLATIONS

- 2.2. Check-in time is at 14:00 and check-out time is at 12:00 (noon).
- **2.3.** Early check-in is subject to availability, unless it is guaranteed by reserving the room from the previous evening at the applicable full night rate. Late check-out: at charge, subject to availability
- **2.4.** Cancellations are accepted only in writing. Cancellations within h. 12:00 (noon) local time 2 days prior to arrival will not be charged. After these terms the hotel will charge the amount of the first night. Attn: **For stays from 5 nights on, the penalty applied will be 3 nts.**

- 4.2. Should the above condition be not respected, it will constitutes a violation of this agreement by the Agent, and it will automatically terminate.
