Rates are per double room, per night, net hotel and inclusive of buffet breakfast, VAT and service. Any eventual City TAX has to be paid cash by the guest directly to the hotel. The extra bed charge is € 70,00 during high and mid season and peak period and € 40,00 during low season.

Cancellation policy

Our cancellation policy is 8 days prior 12.00 on arrival date (hotel Local time). The penalty for late cancellation or no show is equal to the cost of the first night.

Special Offers

For stays of at least 3 nights we offer a 15% discount and for stays of at least 2 nights we offer a 10% discount. The special offers can be extended but are not cumulative and are valid in the following periods: from 01.01.20 to 13.02.20, from 16.02.20 to 20.02.20, from 23.02.20 to 30.04.20, from 19.07.20 to 27.08.20, from 01.11.20 to 29.12.20.

Children Policy

Children up to 3 years of age can stay free of charge, from 3 to 6 years old we offer a 50% discount on third bed rate (when the room is shared with 2 parents).

Groups Policy

Bookings attributable to the same customer of 5 or more rooms on the same arrival date, are considered as a group, therefore the cancellation policies will be different.

Minimum Stay

In the peak period WE, on weekends (Friday and Saturday) of medium and high season, the and 31.12.20, a minimum stay of 2 nights is required.

Room distribution clause

The Partner can promote and distribute the rooms on each market unless otherwise communicated by the hotel. See blacklist (ATT1) which indicates the channels / intermediaries to be excluded from the sales. Any other restrictions may be communicated by the hotel during the course of the year. In the event that the partner does not accept / respond formally, the hotel will consider the conditions automatically accepted, including penalties. The partner will be responsible for the sales distribution, and ensures that descriptions and photos are updated in their systems and also in those of their partners / customers, so that the descriptive information of the rooms will reach the final customer correctly. Any complaint deriving from the noncompliance with this clause (proof must be provided by the customer about the incorrect description) and costs related to the transfer of the client or reimbursement of the stay will be charged to the partner. In case verified by the hotel (through self-booking or other means) the marketing on channels present in blacklist or within an OTA (or other intermediary) with errors or descriptive deficiencies about the room and / or conditions rates (inclusions, cancellation policies, etc ...) and / or general descriptions of the hotel, a penalty of 40 € will be applied. This penalty will be applied to each check made / room night booked. This penalty will be added any costs related to the cancellation of the booked room.
